

Qont Privacy Policy

Privacy Philosophy

Qont believes privacy is control and trust. People should know what happens to their information, they should be able to choose how it is used, and they should be able to ask for changes or deletion. Qont designs the service so that information is used only to provide the paid service, not for advertising or resale. The goal is simple, Qont helps users understand risk while keeping their information safe.

Scope

This policy applies to all users and clients of Qont, and to all employees and contractors of Qont. It applies in every region where Qont operates. Local laws may add rights or duties, and Qont respects those laws while keeping this same standard of care everywhere.

Information Qont Handles

Qont does not collect or retain user inputs for analysis. When a person takes a picture, uploads a document, pastes text, or sends a custom request into Qont, that information is used only to provide the paid service and is not kept. Qont does collect basic account details for login and support, such as name, contact details, and general account settings. Qont also handles employee and contractor details for identification, payment, HR needs, and investigations if there is a breach or a conduct concern. Qont does not collect information for advertising, and it does not sell information.

Inputs and Analysis

Qont provides Portable Risk Intelligence. People can take pictures, upload documents, paste text, or request custom inputs. Qont analyzes that information in seconds, shows a score, and suggests mitigations. Qont processes inputs only to provide that result, then the inputs are not retained. The person can choose to apply a mitigation or not. If applied, Qont shows the updated risk. Qont does not store, sell, or misuse user inputs.

How Qont Uses Information

Qont uses information only to provide and support the paid service, to run accounts, to answer support requests, and to meet legal duties. For employees and contractors, Qont uses information for HR, identification, payments, and investigations in case of breach or conduct issues. Qont does not use information for advertising. Qont does not sell information. If the law requires Qont to keep some records, Qont keeps only what is needed and only for as long as needed.

Cookies and Similar Tools

Qont may use cookies and similar tools to run the website and service, for things like sign in, session safety, language settings, and performance. These cookies are for function and security. Qont does not use cookies for advertising. People can manage non-essential cookies in their browser. Some cookies are essential for the service to work.

Third-Party Services and Integrations

People may choose to connect Qont with other platforms and tools. Those services have their own privacy rules and may collect information in a different way. Qont cannot promise that third parties will follow the same ethics or standards. Qont limits the connection to what is needed to provide the requested function, and Qont does not sell or reuse information from those connections. When people use third-party services, their terms and policies apply.

User Controls and Requests

People can ask Qont to delete their account data, or to use their data in a specific way, where allowed by law. People can also ask for a copy of their account information, or to correct basic details. Qont provides a dedicated privacy request portal for these actions. Qont answers requests in a reasonable time and shares the outcome clearly.

Security

Qont maintains strict security standards. Access is limited to trained staff who need it to provide the service or to handle HR and compliance duties. Qont uses trusted methods to protect information in transit and at rest where storage is required, and Qont reviews security controls on a regular cycle.

Children

Qont does not knowingly work with or collect data from people under 16 years of age. Qont operates a separate Children's Privacy Policy for any services that may involve young people under lawful programs with proper consent and controls. If Qont learns that information from a person under 16 has been provided in error, Qont will delete it upon notice.

Employees and Contractors

Qont handles employee and contractor data for HR, identification, payments, and investigations if there is a breach or a conduct concern. Qont does not use this data for sales, and Qont keeps it securely with limited access. When the working relationship ends, Qont keeps only what is needed to meet legal duties, then removes it when it is no longer required.

International Processing

Qont provides a global service, so information may be processed in more than one country. Qont uses safeguards that meet legal duties for cross-border transfers and keeps the same standard of privacy and security everywhere.

Changes and Updates

Qont may update this policy to reflect new features, legal needs, or better protections. When there is a significant change, Qont will post the update in the Legal Library page and will make the change clear.

Contact and Requests

People can use the privacy request portal to ask for deletion, access, correction, or specific controls. For general privacy questions, people can contact Qont support. Qont will respond in a clear and timely way.

Your Agreement

By using Qont services, people agree to this Privacy Policy and to any rules linked from it, including the Children's Privacy Policy and the Legal Library page. If a person does not agree, they should stop using the service and contact support for options.
