



Qont Software Policy

Purpose

This policy explains how Qont software is licensed, accessed, and protected. It defines permitted use, sets limits that prevent copying or theft, and explains how Qont manages updates, security, and enforcement. It applies to all people who access Qont software and services.

Scope and Global Application

This policy applies to all Qont software and related materials in every country where Qont operates. All users, clients, employees, contractors, partners, and vendors must follow these terms, Qont applies one global standard.

License Grant and Authority

Qont grants a limited, non transferable, non exclusive right to access the software as a service. No ownership of the software is transferred, no source code rights are granted, and no rights exist beyond what this policy and a written agreement provide. Only Qont's authorized representatives may grant permissions in writing, informal or verbal permissions are not valid.

Access Model

Qont software is provided as a hosted service, users access it through approved interfaces, there are no download rights for general users. For business customers, Qont may provide limited downloadable tools for defined purposes, these remain contained and controlled by Qont at all times.

Protected Materials

Software names, interfaces, workflows, logic, code, scripts, documentation, training materials, and system visuals are protected. These materials are intellectual property of Qont and are covered by copyright, trademark, and trade secret laws.

Data Ownership and Platform Rights

Data that users enter or upload remains the property of the user, the software and platform logic remain fully owned by Qont. Use of the software does not grant any rights to Qont's underlying technology or designs.

Use Restrictions

Reverse engineering, copying, exporting, scraping, framing, reproducing, translating, modifying, decompiling, disassembling, redistributing, reselling, sublicensing, or creating derivative works from Qont software are strictly prohibited. Attempts to bypass access limits, remove notices, or interfere with security are not allowed.

Account and Access Control

Accounts, credentials, and keys must be kept private and secure, they may not be shared, transferred, or sold. Users are responsible for actions taken through their accounts, Qont may require credential resets when risk is detected.

Monitoring and Diagnostics

Qont may collect service diagnostics, performance signals, and security events to operate, protect, and improve the service. These signals are used for functionality, quality, and security, not for advertising or resale, handling is subject to the Qont Privacy Policy.

Third Party Software and Integrations

When users connect third party tools or APIs, those components remain under their own licenses and policies. Qont is not responsible for third party security, conduct, or availability, connections are limited to what is needed for the requested function.

Compatibility and Interoperability

Compatibility with external systems is not guaranteed unless Qont supplies or approves the integration. Qont may modify interfaces when needed for security, performance, or product improvements.

Security Testing and Research

Any security testing, penetration testing, scanning, or research on Qont systems requires prior written authorization from Qont. Unapproved testing is unauthorized use and may lead to suspension and legal action.

Updates and Maintenance

Qont manages updates, maintenance, and feature changes, continued use of the service includes acceptance of these updates. Qont may add, modify, or remove features to improve security, stability, and user experience.

Trial and Temporary Access

Trials, demos, and evaluations are subject to this policy. Temporary access must not be copied, exported, or retained after the period ends, Qont may disable access and remove trial data according to the Qont Privacy Policy.

Ownership of Feedback

Ideas, comments, and suggestions shared with Qont may be used to improve products and services, Qont may use feedback without obligation or compensation. Do not include confidential information from other sources in feedback.

Internal Compliance

Employees, contractors, and partners are bound by this policy. Materials created in the course of work or using Qont resources belong to Qont, internal users must not grant rights or share assets without written approval.

Unauthorized Use

Hacking, botting, automated scraping, duplicating environments, or any attempt to gain access beyond granted rights is a breach of this policy and may be a breach of law. Qont may investigate, suspend access, and take action where needed.

Enforcement and Violations

Qont may suspend or terminate access for misuse or breach, may disable features or keys, and may send notices to prevent harm. Qont may issue takedowns and pursue legal action when required to protect its software and users.

Regional Use and Restrictions

Use is not permitted in regions subject to restrictions, embargoes, or where the service is not allowed by law. Users must comply with export and local use controls, Qont may restrict access to meet legal duties.

Disclaimer and Limitation of Liability

The software is provided as is and as available, subject to applicable law. Qont does not accept liability for loss, damage, or interruption arising from use of the service, except where the law does not allow such limits.

Linked Policies and Agreement

Use of Qont software is subject to the Qont Privacy Policy, the Qont Intellectual Property Policy, the Qont Copyright Policy, the Qont Trademark Policy, and the Terms of Service. By using the software, users agree to these documents and any rules linked from them.

Audit and Compliance Review

Qont may review logs and access records for security, maintenance, and compliance, handling follows the Qont Privacy Policy. Reviews help prevent misuse and improve service quality.

Governing Law and Jurisdiction

This policy and any dispute or violation are handled under the laws and courts of the jurisdiction where Qont is headquartered, unless another law requires a different forum.

Non Waiver

Failure to enforce any part of this policy does not waive Qont's rights, Qont may enforce the policy at any time.

Changes and Updates

Qont may update this policy to improve clarity or reflect new features and protections, updates will be posted in the Legal Library page, the most recent version applies.

Contact and Reporting

Questions, suspected misuse, and license requests can be submitted through the compliance or reporting portal, Qont will review and respond in a reasonable time.
